**VENUE OF PM&ET AND DOWNLOAD OF ADMIT CARD**

In response to A & N Administration's Vacancy Notice No. 4-12/2023-R&E Cell/462 dated 26.05.2023. Candidates who have applied exclusively for the posts of Andaman & Nicobar Police are hereby informed that they can download the Admit Card for appearing in Physical Measurement and Endurance Test (PM&ET) which will commence at different centres from 01/07/2023 onwards by visiting the below mentioned links in the website. The Admit Card can be downloaded w.e.f 28/06/2023 at 1100 hrs.

The Physical Measurement & Endurance Test will not carry any marks but will be of qualifying nature. Those candidates who are declared not qualified in Physical Standards, i.e., height and chest may prefer an appeal, if they so desire, to the Appellate Authority. The decision of the Appellate Authority will be final and no further appeal or representation in this regard will be entertained. Candidates are essentially required to qualify in the Physical Measurement and Endurance test to be considered for further course of examination.

Candidates are also advised to familiarize themselves regarding their Centre of Physical Measurement and Endurance Test, Application Number allotted, and other details given in Admit Card, well in advance. Candidates facing difficulties in downloading Admit Card due to slow internet speed or any other technical snags beyond the control of A&N Police, are advised to collect their Admit Card personally from Recruitment Cell, A&N Police Headquarters, Atlanta Point, Port Blair. Admit Card to candidates will be issued till one day prior to commencement of Physical Measurement & Endurance Test. **In case, two different dates are given in the Admit Card for PM&ET, candidates are advised to download two copies of the Admit Card for appearing in the PM&ET on the respective dates.**

**Document Verification:-** Candidates appearing for PM&ET at the assigned Venues are directed to bring their original certificates pertaining to age, education, SC/ST/OBC/EWS, Sports certificate, NCC Certificates, Driving License (2 Wheeler and/or LMV license), age relaxation related documents, criminal antecedents related documents (if any) and other essential requisite documents for verification. A self-attested photocopy of each certificate/document along with the hardcopy of online application form shall have to be provided to the verification board at the time of document verification.

Candidates are further advised to strictly adhere to the instructions given in Admit Card and Recruitment Notice. For any updates related to this recruitment process, keep visiting our website <http://police.andaman.gov.in>.
